### **ABOUT THE ARTIST:**

Stephanie Forbes (b. 1991) is an Augusta, Georgia native currently located in Savannah Georgia where she studied Fine Art at the Savannah College of Art and Design, graduating Magna Cum Laude, in 2019. Before moving to Savannah, Forbes studied art at the Augusta State University. In 2011, she took over Gaartdensity Art Gallery in downtown Augusta, GA; managing all gallery operations and hosting monthly showcases featuring various local and nationwide artists. Post gallery, Forbes moved to Northern California where she gained diverse experience working as a photo editor for the "What I Be Project," graphic design and marketer for Farm Fresh to You, art restorer at Postino in Lafayette, and a freelance/ commission painter and illustrator for clients up and down the west coast.

After graduating, Forbes focused on consecutive passion projects that included 'Fronde Luminary, a series of contemporary portrait paintings of celebrities, where Forbes took the project to multiple venues across Georgia. 'RO3 Gallery' where Forbes opened a gallery and exhibition space, in downtown Savannah. And, 'Lonely Hearts,' a collaboration with the Humane Society of Greater Savannah where Forbes painted contemporary portraits of senior dogs and hosted pop up exhibition events with the portraits and dogs on site. During this time Forbes also completed 2 full time residency Programs with the Savannah College of Art and Design as and Alumni Atelier Associate. This Program led to a collaboration with the Emeline, a boutique hotel located in down town Charleston South Carolina where Forbes completed a third residency program and opened her series, 'Divine Armor and the Lowcountry' in the hotel's Exhibition hall.
